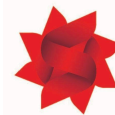

Winery/Distillery Application Information

Please read carefully as the application is updated annually.

The Salem Art Association is accepting applications for this year's event. There will be approximately 5-8 winery/distillery booths at the event. Wineries and Distillers are encouraged to offer tastings, sales by the glass (per OLCC permit), and sealed bottle sales for customers to take home. Winery/Distiller shall provide goods and services as specified in this application for the duration of the Salem Art Fair & Festival, September 11, 12, & 13 of 2026. For the participation fee of \$575.00 and 1 case of wine (for festival hospitality use).

Winery/Distillery Booth Requirements:

- Provide Festival with proof of OLCC permit and Liquor Liability Insurance naming the Salem Art Association and the City of Salem as additional insured.
- Provide proof of OLCC application and authority to operate at the Salem Art Fair & Festival.
- All booths must adhere to appearance standards - tables will be covered and draped on the sides exposed to the public and boxes will be covered or stored out of sight. Signage will be in good taste and will be constrained to the assigned booth area. No sale signs are permitted.
- Provide an inclusive list of products/goods to be sold along with their pricing.
- Winery/Distiller shall equip booths with an approved fire extinguisher (multi-purpose 2A 10BC minimum rating).
- All Winery/Distiller Vendors are to provide their own interior and exterior lighting (not to exceed 75 watts and a 50' 12-gauge extension cord).
- Only electrical items listed on your contract are allowed. Personal coffee makers are not allowed.
- Liability insurance for at least \$1,000,000 is required. Both the Salem Art Association and the City of Salem must be listed as additional insured for the dates of the Art Fair. Proof of additional insured is due with the signed contract.

SAA:

- Will provide the space and placement for your booth.
- Will provide a site map with booth location at least 45 days prior to event dates.
- Will provided a 10' x 10' High Peak Canopy, two 8' tables, and two chairs.
- Will provide food waste containers.

Salem Art Fair & Festival's Terms of Service

Application and SAF&F Booth Layout:

Wine Court applications must include proof of insurance. Documentation verifying that the City of Salem and Salem Art Association as additionally insured is due with the contract on June 19, 2026. Incomplete applications/verifications will not be considered for participation.

Salem Art Association reserves the right for vendor booth placement. Salem Art Association also reserves the right to accept or deny any items or vendors for the Art Fair. Past participants must reapply each year and are not guaranteed acceptance.

Participation Fee:

Upon acceptance into SAF&F, the \$575 fee is due on or before June 19, 2026, to secure your placement.

Inclusivity and Diversity:

The Salem Art Fair & Festival is committed to a policy of inclusivity and diversity. By applying to the Art Fair, you agree to uphold the values and mission of the SAA. Any vendor or artist who promotes a message of hate or intolerance will not be permitted to participate in the Salem Art Fair & Festival.

Indemnification:

Each party (the "Indemnifying Party") agrees to indemnify, defend and hold harmless the other party (the "Indemnified Party") from and against any loss, claim, liability, damage, costs, or expense of any kind (including reasonable attorneys' fees).

This agreement shall commence upon execution by both parties and shall terminate upon the fulfillment of both parties' obligations hereunder with respect to the Salem Art Fair & Festival.
